INQUBOMGOMO YEMIHLAHLANDLELA YEQEMBU YEZEHLAKALO EZIBUCAYI

Isibopho sokunganyelwa kwezehlakalo ezibucayi silele kulezo zimenenja ezisondelene kakhulu nenkinga. Nokho, uma kwenzeka ise hlakalo esingase siholele emiphumeleni emibi kakhulu kubantu, empahleni noma egameni labakwa-Brambles njengesakhamuzi sezamabzhizini, lokhu kufanele kutshelwe ubuholi obuphezulu ukuze kuhlonyswe ngezinsizakusebenza ezifanele zokubhekana nenkinga.

Kuze kube manje, ise hlakalo esibucayi yilesu esibandakanya (ngisho noma esingase sibandakanye) okukodwa noma ngaphezulu kwaloku okulandelayo:

- Uku dlula emhlabeni kwabasebenzi, osozinkontileka noma umphakathi;
- Ize hlakalo ezi holela (noma ezingase zi holele) emonakalweni obucayi emvelweni;
- Ukuchezuka noma ukuzama ukuchezuka izinqubomgomzezezimali, izilawuli zangaphakathi zezimali, izindaba zocwaningomabhuku, kubandakanya ukukhwabanisa noma iphutha lenhloso emalungiselelweni, ukuhlaziwa, ukubukezwa, noma ucwaningomabhuku Iwamarekhodi ezimali kwa-Brambles noma ukuphanjiwa kwezitativemende zezimali noma izitativemende mbumbulu mayelana nezindaba ezi qethwe kumarekhodi ezimali akwa-Brambles, imibiko yezimali, noma imibiko yocwaningomabhuku;
- Izenzo zangempela noma ezingase zenzeke noma zokukhwabanisa noma ukushayisana kwezintshisekelo;
- Ukwaphulwa kwe-US Foreign Corrupt Practices Act, UK Bribery Act okwenzekile noma okungase kwenzeke, nanoma yimuphi omunye umthetho wokugwaza noma ohlobene nenkohlakalo;
- Ukuhlaselwa kwasekuzeni kokusa noma olunye uphenyo olwenziwa umlawuli noma isikhungo sabomthetho sasendaweni; kanye
- Ize hlakalo ezi holela (noma ezingase zi holele) ekulandelweni ngabezindaba kakhulu, ukuboshwa kwezigebengu noma ukuvulelwicalaelikhulu, ukumiswa komsebenzi okukhulu, noma ukulinyazwa kwempahla noma isikweletu semali (emva komshuwaleensi) esingaphezu kwama- GBP 400,000; USD 500,000; AUD 1,000,000; noma ama-Euro 600,000.

Lapho ezwa ise hlakalo esibucayi, iNhloko YezoMthetho iyokwazisa futhi icebise isiKhulu esiyiNhloko ePhezulu kanye namalungu asele eThimba Lobuholi obuPhezulu, njengokufanele. IBhodi yakwa-Brambles inesibopho esib=ngujikelele sale Mihlahlandela.

INhloko YezoMthetho, Nonobhala WeQembu LeNkampani bazobukeza lo Mihlahlandela ngasohlangothini lwezomthetho kanye nokwenziwa komsebenzi okungenani kanye ngonyaka futhi kufanele baqinisekise ukuthi bonke abasebenzi bayathola ukuqe qeshwa njalonjalo okufanele.

Bonke abasebenzi okungumsebenzi wabo ukuphumelela kwale MIhlahlandela. I-Brambles yakha izindawo zokusebenza lapho kunokuxhumana okuvulelekile nokuthembeka phakathi kwabo bonke

abasebenzi kuyigugu futhi kuhlonishwa. Uma unanoma yimiphi imibuzo mayelana nale Mihlahlandlela, noma uma ungathanda ukubika ngokwephulwa kwayo, sicela ukhulume nemenenja yakho, noma yiliphi ilungu leThimba Lezomthetho noma Lakwandababantu, noma-ke i-Speak Up hotline. Njengokusho kweNqubomgom o yakwa-Brambles i-Speak Up, akukho kuphindiselwa noma ukujeziswa okuzokwenzeka kumsebenzi ophakamise ukukhathazeka ngaphansi kwale miHlahlandlela. I-Brambles izibophezele ekuphenyeni, ukubhekana, kanye nokuphendula konke ukukhathazeka kwabasebenzi kanye nokuthatha izinyathelo ezifanele zokulungisa lokho okuphakanyiswe njengokuphulwa kwayo.
